**Sec. \_\_\_\_.** None of the funds made available by this act may be used in contravention of Executive Order Number 13672 of July 21, 2014("Further Amendments to Executive Order 11478, Equal Employment in the Federal Government, and Executive Order 11246, Equal Employment Opportunity")

Many times during a congressional vote particularly on amendments, things can get overlooked and you has a congressman may wind up voting on something you're not completely aware of. Maybe that is what happened here.

However the Center for Garden State Families is not making excuses for the four New Jersey congressmen who voted in favor of this amendment.
